These rules require firms that are authorised by the SRA to take out and maintain professional indemnity insurance. They do not apply to solicitors, RELs and RFLs that practise outside SRA authorised firms.

Rule 1: Application

1.1 These rules apply to authorised bodies

Rule 2: Obligation to effect insurance

- 2.1 An authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] carrying on a practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice] during any indemnity period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period] beginning on or after 25 November 2019 must take out and maintain qualifying insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] under these rules with a participating insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer].
- 2.2 In respect of its obligation under rule 2.1, an authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] must obtain a policy [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy] of qualifying insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] prior to the expiry of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period], that provides cover incepting on and with effect from the expiry of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period].
- 2.3 If the authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] has been unable to comply with rule 2.2, the authorised body [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#authorised-body] must obtain a policy [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy] of qualifying insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] during or prior to the expiry of the extended policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extended-

policy-period] that provides cover incepting on and with effect from the expiry of the policy period

2.4 If the authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] has been unable to comply with either rule 2.2 or rule 2.3, the authorised body [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#authorised-body] must cease practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice] promptly, and by no later than the expiry of the cessation period [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#cessation-period], unless the authorised body [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#authorised-body] obtains a policy

Rule 3: Adequate and appropriate insurance

have the benefit of the indemnity insurance required under these rules and must not exclude or attempt to exclude liability below the minimum level of cover required under these rules.

Rule 4: Responsibility

- 4.1 Each authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body], and any principal [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of such a body, must ensure that the authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] complies with these rules.
- 4.2 Each authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] that has been unable to obtain a policy [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy] of qualifying insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] prior to the expiration of the extended policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period] and any principal

Rule 5: Insolvency of participating insurer

5.1 If an authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] is carrying on a practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice] which is being provided with qualifying insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] by a participating insurer

[https://www.sra.org.uk/solicitors/standardsregulations/glossary/#participating-insurer] (whether alone or together with another participating insurer [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#participating-insurer]) and that participating insurer [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#participating-insurer] is the subject of an insolvency event [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insolvency-event] then the authorised body [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body] and any principal [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of the body must ensure that the authorised body [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body] has in place qualifying insurance [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance] with another participating insurer [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#participating-insurer] as soon as may be reasonably practicable and in any event within four weeks of such insolvency event [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insolvency-event] .

Rule 6: Monitoring

6.1 The SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may require from an authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] or any principal [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] in an authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body], information and evidence it may reasonably require to satisfy itself that the body has complied with these rules.

Rule 7: RELs

7.1 The provisions contained in annex 2 to these rules apply to an authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] that has at least one principal [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] who is an REL [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL].

Part 3: Reporting

Rule 8: Use of information

8.1 Each authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] must notify the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] (or

Rule 9: Details of participating insurer

9.2

- **9.1** This rule is in addition to any obligations imposed on the authorised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] under the Provision of Services Regulations 2009.

10.1 For the purposes of the SA

SRA Minimum Terms and Conditions of Professional Indemnity Insurance

1. Scope of cover

1.1 Civil liability

Subject to the limits in clause 2, the insurance must indemnify each insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against civil liability to the extent that it arises from private legal practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#private-legal-practice] in connection with the insured firm's practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice], (including its prior practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#prior-practice] and (unless run-off cover is provided in accordance with clause 5.3) any successor practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice]) provided that a claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] in respect of such liability:

(a) is first made against an insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insuduring the period of insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#perinsurance]; Or

(b) is made against an insured

1.2 Defence costs

The insurance must also indemnify the insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] in relation to:

- (a) any claim [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#claim] referred to in clause 1.1; or
- (b) any circumstances [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#circumstances] first notified to the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#inst during the period of insurance;

1.3 The insured

For the purposes of the cover contemplated by clause 1.1, the insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] must include:

- (a) the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm]; and
- (b) each service, administration, trustee or nominee compa [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#con owned as at the date of occurrence of relevant circumstances [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#circumstances] by the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insufirm] and/or the principals [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insufirm]; and

1.4 Award by regulatory authority

The insurance must indemnify each insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against any amount paid or payable in accordance with the recommendation of the Office for Legal Complaints (including the Legal Ombudsman [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman] pursuant to section 137(2)(c) and section 137(4) (b) of the LSA [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#LSA]) or any other regulatory authority to the same extent as it indemnifies the insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against civil liability provided that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will have no liability in respect of any determination by the Legal Ombudsman [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#Legal-Ombudsman] pursuant to section 137(2) (b) of the LSA [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#LSA] to refund any fees paid to the insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] .

2. Limit of insurance cover

2.1 Any one claim The sum insured

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured] for any one claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] (exclusive of defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-

costs]) must be, where the insured firm

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#relevant-recognised-body] or a relevant licensed body

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#relevant-licensed-body] (in respect of activities regulated by the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] in accordance with the terms of the body's licence) at least £3 million, and in all other cases, at least £2 million.

- **2.2 Defence costs** There must be no monetary limit on the cover for defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] .
- 2.3 Proportionate limit on defence costs Notwithstanding clauses 2.1 and 2.2, the insurance may provide that liability for defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] in relation to a claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] which exceeds the sum insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured] is limited to the proportion that the sum insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured] bears to the total amount paid or payable to dispose of the claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] .
- 2.4 No other limit The insurance must not limit liability to any monetary amount (whether by way of an aggregate limit or otherwise) except as contemplated by clauses 2.1 to 2.3 (inclusive).
- 2.5 One claim The insurance may provide that, when considering what may be regarded as one claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] for the purposes of the limits contemplated by clauses 2.1 to 2.3 (inclusive):
 - (a) all claims [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#claim] against any one or more insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#instarising from:
 - (i) one act or omission;
 - (ii) one series of related acts or omissions;
 - (iii) the same act or omission, in a series of relate transactions;

- (iv) similar acts or omissions, in a series of relatetransactions, and
- (b) all claims [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] against one or more insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insu arising from one matter or transaction will be regarded a one claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim].

2.6 Multiple underwriters

- **2.6.1** The insurance may be underwritten by more than one insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer], each of which must be a participating insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer], provided that the insurance is fully underwritten.
- **2.6.2** Where the insurance is underwritten jointly by more than one insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer], the insurance:
 - (a) must state which participating insurer
 [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#participating-insurer] shall be the lead insu
 [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#lead
 insurer];
 - (b) may provide that each insurer
 [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insushall be severally liable only for its respective proportion liability in accordance with the terms of the insurance; a
 - (c) (in addition to any proportionate limit on defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defcosts] in accordance with clause 2.3), may provide that e insurer's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] liability for defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defcosts] is further limited to the extent or the proportion of t insurer's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] liability (if any) in relation to the relevant claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim].
- 2.6.3 The insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] stated to be the lead insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#lead-insurer] shall act as such including without limitation being responsible for the conduct of claims

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim], advancing defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] (subject to clause 2.6.2(c)) and compromising and arranging the payment of claims [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim]. The liability of any insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] shall not be increased by virtue only of the fact that it is acting as lead insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#lead-insurer].

3. Excesses

3.1 The insurance may be subject to an excess

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#excess] of such monetary amount and on such terms as the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] and the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] agree. Subject to clause 3.4, the excess [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#excess] may be 'self-insured' or partly or wholly insured without regard to these MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] .

- 3.2 The insurance must provide that the excess
 [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#excess]
 deductible does not reduce the limit of liability contemplated
- 3.3 The excess [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#excess] must not apply to defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs].

3.4 The insurance must provide that, if an insured

by clause 2.1.

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] fails to pay to a claimant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claimant] any amount which is within the excess [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#excess] within 30 days of it becoming due for payment, the claimant

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claimant] may give notice of the insured's

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] default to the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer], whereupon the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is liable to remedy the default on the insured's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] behalf. The insurance may provide that any amount paid by the insurer [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#insurer] to remedy such a default erodes the sum insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured] .

3.5 The insurance may provide for multiple claims

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] to be treated as one claim [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] for the purposes of an excess [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#excess] contemplated by clause 3.1 on such terms as the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] and the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] agree.

3.6 In the case of insurance written on an excess of loss basis, there shall be no excess [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#excess] except in relation to the primary layer.

4. Special conditions

4.1 No avoidance or repudiation

The insurance must provide that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is not entitled to avoid or repudiate the insurance on any grounds whatsoever including, without limitation, any breach of the duty to make a fair presentation of the risk, or any misrepresentation, in each case whether fraudulent or not.

4.2 No adjustment or denial

The insurance must provide that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is not entitled to reduce or deny its liability under the insurance on any grounds whatsoever including, without limitation, any breach of any term or condition of the insurance, except to the extent that one of the exclusions contemplated by clause 6 applies.

4.3 No cancellation

The insurance must provide that it cannot be cancelled except (in the case of (a), (b) or (c) below) by the agreement of both the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] and the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer], and in any event only in circumstances where:

(a) the insured firm's practice

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insifirm's-practice] is merged into a successor practice
[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice], provided that there is

insurance complying with these MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT relation to that successor practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice], in which case cancellation shall have effect no earlier than the date of merger; or

- (b) replacement insurance, complying with the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT effect at its commencement, commences, in which case cancellation shall have effect no earlier than the date or which such replacement insurance commences; or
- (c) it subsequently transpires that the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insi firm] is not required under the SRA Indemnity Insurance Rules to effect a policy [https://www.sra.org.uk/solicitors/standa regulations/glossary/#policy] of qualifying insurance [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance], in which case cancellation shall have effect from the later of (a) the sta the relevant policy period [https://www.sra.org.uk/solicitors/stan regulations/glossary/#policy-period] and (b) the date on which insured firm [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insured-firm] ceased to be required to ef policy [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#policy] of qualifying insurance [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance], or such later date a insured firm [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insured-firm] and the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insi may agree.

Cancellation must not affect the rights and obligations of the parties accrued under the insurance prior to the date from which cancellation has effect.

4.4 No set off

The insurance must provide that any amount payable by the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] to indemnify an insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against civil liability to a claimant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claimant] will be paid only to the claimant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claimant], or at the claimant's [https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#claimant] direction, and that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is not entitled to set-off against any such amount any payment due to it by any insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] including, without limitation, any payment of premium or to reimburse the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] .

4.5 No 'other insurance' provision

The insurance must not provide that the liability of the insurer [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insurer] is reduced or excluded by reason of the existence or availability of any other insurance other than: (i) as contemplated by clause 6.1; or (ii) where the insured [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insured], having entered the extended policy period [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#extended-policy-period] or cessation period [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#cessation-period], obtains a policy [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy] of qualifying insurance [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance] that incepts from and with effect from the expiration of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policyperiod]. For the avoidance of doubt and subject to the provisions of the participating insurer's agreement [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#participating-insurer's-agreement], this requirement is not intended to affect any right of the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] to claim contribution from any other insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] which is also liable to indemnify any insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] .

4.6 No retroactive date

The insurance must not exclude or limit the liability of the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] in respect of claims [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#claim] arising from incidents, occurrences, facts, matters, acts and/or omissions which occurred prior to a specified date.

4.7 Successor practice - 'double insurance'

The insurance may provide that, if the insured firm's practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] is succeeded during the period of insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-

insurance] and, as a result, a situation of 'double insurance' exists between two or more insurers [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] of the successor practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice], contribution between insurers [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is to be determined in accordance with the relative numbers of principals [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of the owners of the constituent practices [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice] immediately prior to succession.

4.8 Resolution of disputes as to insurer of successor practice

The insurance must provide that, if there is a dispute as to whether a practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice] is a successor practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice] for the purposes of clauses 1.1 or 5.5, the insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] and the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will take all reasonable steps (including, if appropriate, referring the dispute to arbitration) to resolve the dispute in conjunction with any related dispute between any other party which has insurance complying with these MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] and that party's insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer].

4.8A Conduct of a claim pending dispute resolution

The insurance must provide that, pending resolution of any coverage dispute and without prejudice to any issue in dispute, the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will, if so directed by the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA], conduct any claim, advance defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] and, if appropriate, compromise and pay the claim. If the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] is satisfied that:

- the party requesting the direction has taken all reasona steps to resolve the dispute with the other party/ies;
- (b) there is a reasonable prospect that the coverage disput be resolved or determined in the insured's

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#instfavour; and

(c) it is fair and equitable in all the circumstances for such direction to be given,

it may in its absolute discretion make such a direction.

4.9 Advancement of defence costs

The insurance must provide that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will meet defence costs [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#defence-costs] as and when they are incurred, including defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defencecosts1 incurred on behalf of an insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] who is alleged to have committed or condoned dishonesty or a fraudulent act or omission, provided that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] iS not liable for defence costs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defencecosts] incurred on behalf of that insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] after the earlier of:

- (a) that insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] admitting to the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insu the commission or condoning of such dishonesty, act or omission; or
- (b) a court or other judicial body finding that that insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insuwas in fact guilty of such dishonesty, act or omission.

4.10 Variation of insurance terms

The terms of the insurance must provide that the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] shall vary the terms of the insurance to give effect to any variation to the SRA Indemnity Insurance Rules, the Glossary and the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC], such variation to be implemented by the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer]:

(a) on the date of any renewal or replacement of the insura or any extension to the period of insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#per insurance] occurring in that indemnity period [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#indemnity-period]; Or

(b) on each date falling in 18 month intervals from the commencement of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#poli period] where no variation has occurred by reason of clai 4.10(a) within the immediately preceding 18 month peri

save that no variation shall be required under clause 4.10(b) where the date on which variation would have been required is a date within the extended policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period] or the cessation period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period].

4.11 MTC to prevail

The insurance must provide that:

- (a) the insurance is to be construed or rectified so as to conwith the requirements of these MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT (including any amendment pursuant to clause 4.10); an
- (b) any provision which is inconsistent with these MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT (including any amendment pursuant to clause 4.10) is to severed or rectified to comply.

5. Extended policy period and run-off cover

5.1 Extended policy period

The insurance must provide cover complying with the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] for the duration of the extended policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period] where an insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] has not, prior to the expiration of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period], obtained insurance complying with the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] and incepting on and with effect from the day immediately following the expiration of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy-

period].

5.2 Cessation period

The insurance must provide cover complying with the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] for

the duration of the cessation period

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period] where an insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] has not, prior to the expiration of the extended policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period], obtained insurance complying with the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] and incepting on and with effect from the day immediately following the expiration of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period].

5.3 Run-off cover

Subject to clause 5.7 the insurance must provide run-off cover:

- (a) in the event of a cessation [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#ces that occurs during or on expiration of the policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#poliperiod];
- (b) in the event of a cessation [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#ces that occurs during the extended policy period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extentions/period] or the cessation period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period]; Or
- (c) from the expiration of the cessation period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period];

and for the purposes of this clause 5.3 and clause 5.7, an insured firm's practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] shall (without limitation) be regarded as ceasing if (and with effect from the date upon which) the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] becomes a non-SRA firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#non-SRA-firm].

5.4 Scope of run-off cover

The run-off cover referred to in clause 5.3 must:

(a) indemnify each insured [https://www.sra.org.uk/solicitors/standa regulations/glossary/#insured] in accordance with clauses 1.1

1.4;

- (b) provide a minimum level of insurance cover in accordar with clauses 2.1 and 2.3;
- (c) be subject to the exclusions and conditions of the insural applicable in accordance with the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT and

(d) extend the period of insurance

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#per insurance] for an additional six years (ending on the sixth anniversary of the date upon which, but for this requirer it would have ended, and for the avoidance of doubt, including the extended policy period

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#extropolicy-period] and cessation period

[https://www.sra.org.uk/solicitors/standards-

regulations/glossary/#cessation-period],) save that in respect o off cover provided under clause 5.3(c), such run-off cov shall not operate to indemnify any regulated insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insufor civil liability arising from acts or omissions of such insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured] occurring after the expiration ocessation period [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period].

5.5 Succession

The insurance must provide that, if there is a successor practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice] to the ceased practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice], the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] may elect before its cessation [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation], whether it wishes the ceased practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#practice]:

- (a) to be insured under the run-off cover referred to in claus 5.3(a) or
- (b) provided that there is insurance complying with these N [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT relation to that successor practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice], to be insured as a pi

practice [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#prior-practice] under such insurance.

If the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] fails to make an election and/or fails to pay any premium due under the terms of the policy [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy], before its cessation [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#cessation], clause 5.5(b) above shall apply.

- 5.6 Suspended practices The insurance must provide that, where run-off cover has been activated in accordance with this clause 5, but where the insured firm's practice [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] restarts, the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] may (but shall not be obliged to) cancel such run-off cover, on such terms as may be agreed, provided that:
 - (a) there is insurance complying with these MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MT relation to that insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insufirm] in force on the date of cancellation;
 - the participating insurer [https://www.sra.org.uk/solicitors/standaregulations/glossary/#participating-insurer] providing such insurations confirms in writing to the insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] and the insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] (if different) that:
 - (i) it is providing insurance complying with these [https://www.sra.org.uk/solicitors/standards-regulations/g relation to that insured firm [https://www.sra.org.uk/solicitors/standards-regulations/g firm] for the then current indemnity period [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#indemnity-period]; and

regulations/glossary/#insured-firm's-practice] has professional indemnity cover under home professional rules but that the equivalence is only partial (Partial Home State Cover) (including, without limitation, by reason of the provider of the Partial Home State Cover entering into such agreement as the SRA [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#SRA] may require from time to time), the insured firm [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#insured-firm] and its principals [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#principal] shall for so long as such cover continues (and, where the SRA [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#SRA] has required such agreement, for so long as such agreement remains in force and its requirements are complied with by the provider(s) of the Partial Home State Cover that are party to it) be exempted from the obligation to take out and maintain qualifying insurance [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance], on condition that they take out and maintain a difference in conditions policy, which shall provide cover including the MTC [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] as modified by the following changes (but not otherwise):

- (a) Clause 4.5 shall be deleted and replaced with the follow
 - (i) 4.5 No 'other insurance' provision
 - (i) The insurance must not provide that the liabil insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is reduced or exclude the existence or availability of any other insur than as contemplated by clauses 6.1 or 6.12. avoidance of doubt, this requirement is not in any right of the insurer [https://www.sra.org.uk/solic regulations/glossary/#insurer] to claim contribution insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] which is also liable to insured [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured].
- (b) Clause 4.8 shall be deleted and replaced with the follow
 - (i) 4.8 Resolution of disputes
 - (i) The insurance must provide that, if there is a whether a practice [https://www.sra.org.uk/solicitors/ regulations/glossary/#practice] is a successor practi

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice] for the purp clauses 1.1, or 5.5, the insured [https://www.sra.org.uk/solicitors/standards-regulations/g and the insurer [https://www.sra.org.uk/solicitors/stan regulations/glossary/#insurer] will take all reasonab resolve the dispute in conjunction with any re between any other party which has insurance with these MTC [https://www.sra.org.uk/solicitors/stan regulations/glossary/#MTC] and that party's insurer conjunction with the provider of the Partial Hc Cover [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover] .

- (c) Clause 4.12 shall be added:
 - (i) 4.12 Period of insurance
 - (i) The period of insurance must not expire prior with effect on which the Partial Home State C [https://www.sra.org.uk/solicitors/standards-regulations/g Home-State-Cover] expires or is avoided.
- (d) The following clause shall be added:
 - (i) 6.12 Partial Home State Cover
 - (i) The insurance may exclude any liability of the extent that any such liability is covered under the Partial Home State Cover [https://www.sra.org.uk/solicitors/standards-regulations/g Home-State-Cover] irrespective of whether recovmade in respect of such liability.
- 1.3 In the event of an insured firm
 - [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] which has the benefit of an exemption under paragraph 1 or paragraph 2 of this annex ceasing for whatever reason to enjoy that exemption but continuing to carry on a practice it shall be treated for all the purposes of these rules as though it had commenced the practice on the date when such exemption ceased.
- 1.4 Rule 5 (Insolvency of Participating Insurer) shall apply to an insured firm [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] which has the benefit of an exemption under paragraph 1 or paragraph 2 of this annex in like manner as though the insurance company or entity or fund providing professional indemnity cover under its home professional rules, on the basis of which exemption or partial



exemption was granted, was a participating insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer] .

1.5 In the case of an insured firm

[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] which has the benefit of an exemption under paragraph 2 of this annex all the provisions of these rules shall apply to the additional professional indemnity insurance required under that paragraph to be taken out with a participating insurer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer] .

indemnity period

means:

- i. in the SRA Indemnity Insurance Rules and the MTC, the period of one year starting on 1 September 2000, 2001 or 2002, the period of 13 calendar months starting on 1 September 2003, or the period of one year starting on 1 October in any subsequent calendar year
- ii. in the SRA Indemnity Fund Rules, the period of one year commencing on 1 September in any calendar year from 1987 to 2002 inclusive, the period of 13 calendar months commencing on 1 September 2003, and the period of one year commencing on 1 October in any subsequent calendar year.
