Rule 1

In the SRA Code of Conduct 2011, in note (ii) to Chapter 6, replace "Financial Services Authority" with "Financial Conduct Authority".

Rule 2

Appendix 5 to the SRA Accounts Rules 2011 shall be amended as follows:

- (b) replace the address on the last page of the form with the following:

Rule 3

The SRA Practice Framework Rules 2011 shall be amended as follows:

- in rule 10.2(c)(iii), replace "paragraph (c) of the definition of "Private practice" in Appendix 4 to the SRA Indemnity Insurance Rules" with "paragraph (i)(E) of the definition of *private practice*";
- (b) in Guidance note (iii) to Rule 8, replace "Financial Services Authority" with "Financial Conduct Authority", and replace "FSA" (in each case) with "FCA".

Rule 4

The SRA Training Regulations 2011 Part 1 – Qualification Regulations shall be amended as follows:

(a) in regulation 6.1(d), replace "FILEX" with "Chartered Legal Executive";

- (b) in regulation 6.1(e), replace "*MILEX*" with "*Graduate of CILEx*";
- (c) in regulation 7.3, replace "*FILEX*" with "*Chartered Legal Executive*", "*MILEX*" with "*Graduate of CILEx*", and "ILEX" with "CILEx";
- (d) in the guidance note following regulation 22.2, insert a new paragraph (viii) as follows: "The *part time study training contract* may also be used where an *LPC* student has resits to complete within the allowed five year period.";
- (e) in regulation 29.2(b), replace "FILEX" with "Chartered Legal Executive";
- (f) in the title of Part 7, replace "FILEX, MILEX" with "CILEx";
- (g) in the title of regulation 30, replace "FILEX" with "Chartered Legal Executive";
- (h) in regulation 30.1, replace "*FILEX*" (in each case) with "*Chartered Legal Executive*";
- (i) in the title of regulation 31, replace "MILEX" with "Graduate of CILEx";
- (j) in regulation 31.1, replace "*MILEX*" with "*Graduate of CILEx*".

Rule 5

The SRA Suitability Test 2011 shall be amended as follows:

- (a) in guidance note (vi) at the end of section 1.3, replace "Serious motoring" with "Motoring";
- (b) in guidance note (i) at the end of section 2.2, replace "We will also perform a PNC check at the student enrolment stage and have reciprocal arrangements with other jurisdictions in order to gather similar information on lawyers from other countries." with "We also reserve the right to require applicants to provide a PNC check.";
- (c) in guidance note (ii) at the end of section 6.2, replace "will" with "may".

Rule 6

The SRA Financial Services (Scope) Rules 2001 shall be amended as follows:

- (a) in rules 1.1, 1.2(a), 2.1, 4.1(f), 5.6(b) and 6.3(b), replace "*FSA*" (in each case) with "*FCA*";
- (b) in rule 5.6(a), replace "FSA Register" with "Financial Services Register";
- (c) in note (i) to rule 1, replace "FSMA makes the FSA the single statutory regulator of financial services business" with "FSMA makes the FCA and the Prudential Regulation Authority (PRA) the statutory regulators of financial services business" and replace "FSA" with "FCA";
- (d) in note (i) to rule 2, replace "*FSA*" with "*FCA*" and replace "*FSA*'s requirements" with "*FCA*'s requirements";

- (e) in note (ii) to rule 4, replace "FSA" with "FCA"; and
- (f) in note (i) to rule 5, replace "FSA's Exempt Professional Firms (EPF) Register" with "FCA's Exempt Professional Firms (EPF) Register", and replace "FSA website - see www.fsa.gov.uk" with "FCA website - see www.fca.org.uk".

Rule 7

The SRA Financial Services (Conduct of Business) Rules 2001 shall be amended as follows:

- (a) in rules 1.1, 1.2, 2.2(a), 2.2(b), 3.1 and 3.2(a) of Part 1, replace "*FSA*" (in each case) with "*FCA*";
- (b) in rule 3.3 of Part 1, replace "Financial Services Authority" with "Financial Conduct Authority" and "www.fsa.gov.uk/register/home.do" with "www.fca.org.uk/register";
- (c) in paragraph 5 of Appendix 1, replace "*FSA*" with "*FCA*", "*FSA's* Supervision Manual" with "*FCA's* Supervision Manual", and "*FSA's* Professional Firms' Sourcebook" with "*FCA's* Professional Firms' Sourcebook";
- (d) in note (iii) to paragraph 1 of Appendix 1, replace "FSA" with "FCA"; and
- (e) in note (ii) to paragraph 3 of Appendix 1, replace "FSA" with "FCA".

Rule 8

The SRA Handbook Glossary 2012 shall be amended as follows:

(a) after the definition of "charity" insert:

"Chartered Legal Executive

means a Fellow of the Chartered Institute of Legal Executives.";

(b) after the definition of "extended indemnity period", insert:

"FCA

means the Financial Conduct Authority.";

- (c) delete the definition of "**FILEX**";
- (d) after the definition of "financial institution", insert:

"Financial Services Register

means the record maintained by the *FCA* as required by section 347 of *FSMA* and including those *persons* who carry on, or are proposing to carry on, *insurance mediation activities*.";

(e) delete the definition of "FSA";

- (f) delete the definition of "**FSA Register**";
- (g) after the definition of "general prohibition" insert:

"Graduate of CILEx

means a Graduate member of the Chartered Institute of Legal Executives.";

- (h) delete the definition of "**MILEX**"; and
- (i) in the definition of "**non-mainstream regulated activity**", replace "*FSA*" with "*FCA*".

Rule 9

These amendment rules shall come into force on 1 April 2013 and are exempt from the Legal Services Board approval under the Exemptions Direction 1 Alterations falling below a de minimis line (paragraph 19(3) and (4) of Schedule 4 direction).
