

# Application for a waiver - Qualified Lawyer Transfer Scheme (QLTS)

Read our guidance before completing this application.

You should submit this waiver application at the same time as applying to us for admission. Please make sure you confirm which Objective Structured Clinical Examination (OSCE) sitting you passed and why you did not complete your admission application before 1 September 2021.

We may grant a waiver when we are satisfied that, in your specific circumstances, a waiver is compatible with the regulatory objectives in section 1 of the Legal Services Act 2007.

#### These are:

- a) protecting and promoting the public interest
- b) supporting the constitutional principle of the rule of law
- c) improving access to justice
- d) protecting and promoting the interests of consumers
- e) promoting competition in the provision of services within subsection (2)
- f) encouraging an independent, strong, diverse and effective legal profession
- g) increasing public understanding of the citizen's legal rights and duties
- h) promoting and maintaining adherence to the professional principles.

We usually publish a summary of waiver decisions. However, we have decided that in accordance with the SRA's guidance on waivers, any individual waiver decision that we make because of the application will not be of relevance to other regulated individuals or firms or the wider public interest. We have already communicated our general approach to this issue on our website or directly to the candidates this affects.

Our <u>Waivers Guidance</u> provides more information about which of our rules and regulations can be waived and our general approach to granting waivers.
