### **Decision details**

David Berens' practising certificate for 2023/2024 is subject to the following conditions:

1. Mr Berens shall not act as a manager or owner of any authorised body.
2. Mr Berens may not act as a Compliance Officer for Legal Practice (COLP) or Compliance Officer for Finance and Administration (COFA) for any authorised body, or Head of Legal Practice (HOLP) or Head



of Finance and Administration (HOFA) in any authorised non-SRA firm.

3. Mr Berens does not hold, receive, or have access to client money, or does not act as a signatory to any client or office account, or have the power to authorise electronic transfers from any client or office account.

In these conditions the terms are as defined in the SRA Glossary.

#### **Reasons/basis**

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.

### **Outcome details**

This outcome was reached by SRA decision.

**Reasons/basis**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which reaches its own decision after considering all the evidence, including any evidence put forward by the Respondent. The Tribunal had certified that there was a case to answer.

On 9 March 2023 the SDT considered and approved an Agreed Outcome.

Mr Berens was fined £7,501 and was made subject to the following restrictions on his practice for an indefinite period:

- Mr Berens shall not act as a manager or owner of any authorised body.
- Mr Berens may not act as a Compliance Officer for Legal Practice (COLP) or Compliance Officer for Finance and Administration (COFA) for any authorised body, or Head of Legal Practice (HOLP) or Head of Finance and Administration (HOFA) in any authorised non-SRA firm.
