- 2. The Solicitors' Indemnity Rules 1987 as amended from time to time shall be further amended with effect from 1 October 2023 and shall continue in force thereafter in the form annexed hereto in which form they may be known as the SRA Indemnity Fund Rules.
- 3. The Solicitors' Indemnity (Incorporated Practice) Rules 1991 as amended from time to time shall continue in force only in respect of the <a href="indemnity-periods">indemnity-periods</a> <a href="[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012]</a> commencing on 1 September 1991 and 1 September 1992.

The <u>contributions [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#contributions-2012]</u> payable in respect of the <u>indemnity periods [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012]</u> commencing prior to 1 September 1996 shall remain unaltered.
