### **Reasons/basis**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that Mr Tanwar :-

- Provided misleading information to the Court as to his location during a hearing in August 2023, when questioned by the Court as where he was located at the time of the hearing.
- Failed to attend an in-person hearing as required by a Court Order and/or failed to arrange for a suitable representative to attend to cover for him.

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.
