2. Mr Mawbey-Shaw may not be a compliance officer for legal practice (COLP) or a compliance officer for finance and administration (COFA).
3. Mr Mawbey-Shaw must not practise on his own account under regulation 10.2(a) or (b) of the SRA Authorisation of Individuals Regulations.

**Reasons/basis**

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the
