   a manager or employee of Berkeley Hurrell Limited, to be the
   designated Compliance Officer for Legal Practice (COLP) of Berkeley
   Hurrell Limited.

This waiver is subject to the following conditions:

- i. Mr Gavin must at all times remain a manager and COLP in at least one other of the Irwin Mitchell group companies;
- ii. Mr Gavin must remain as Company Secretary of Berkeley Hurrell Limited:
- iii. Berkeley Hurrell Limited must continue to have its day-today compliance work carried out by the Risk & Compliance team for the Irwin Mitchell group of companies; and
