Decision details

To intervene into the practice of Dominic Leon Macknight at Lawson Taylor Solicitors Ltd.

Reasons/basis

1. The Panel was satisfied that grounds for intervention existed under paragraph 1(1)(a) of Schedule 1 to the Solicitors Act 1974 (as amended) namely that was reason to suspect dishonesty on the part of Dominic Leon Macknight in connection with his practice at Lawson Taylor Solicitors Ltd.
2. The Panel was satisfied that grounds for intervention existed under paragraph 1(1)(c) of Schedule 1 to the Solicitors Act 1974 (as amended) namely that Dominic Leon Macknight had failed to comply with the rules made under sections 31 and 32 of the Solicitors Act 1974 (as amended).
