#### **Decision details**

Richard Tinkler's practising certificate for 2024 / 2025 is subject to the following conditions:

- 1. Mr Tinkler shall not act as a manager or owner of an authorised body.
- 2. Mr Tinkler may act as a solicitor, only as an employee and only where that employment has first been approved by the SRA.
- 3. Mr Tinkler does not hold or receive client money, or act as a signatory to any client or office account or have the power to authorise transfers from any client or office account.
- 4. Mr Tinkler may not act as a compliance officer for legal practice (COLP) or compliance officer for finance and administration (COFA) for any authorised body.

#### Reasons/basis



The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.
