2. Subject to condition 1, Mr Ford may act as a solicitor only as an employee and only where that employment has first been approved by the SRA.
3. Mr Ford may not act as a compliance officer for legal practice (COLP) or a compliance officer for finance and administration (COFA) for any authorised body.



4. Mr Ford does not hold or receive client money, or act as a signatory to any client or office account or have the power to authorise transfers from any client or office account.
