2. Mrs Boye's employment at JDS Solicitors Limited is limited to that as provided by the firm to the us within the following documents:

 - email from JDS Solicitors Limited to us dated 25 August 2020.
3. Any proposed variation to Mrs Boye's duties, or arrangements as to her supervision are notified to us in advance of the change taking place and that the variation must not take place until we have granted permission.
4. Mrs Boye shall not have any responsibility for or be involved in the training or supervision of any other employee at JDS Solicitors Limited.
