## *Solicitors Qualifying Examination (SQE)*

Our Board have decided to introduce a single, rigorous assessment for all aspiring solicitors on 1 September 2021.

The SQE will mean everyone meets the same consistent, high standards at the point they become a solicitor.

This is supported by our Statement of Legal Knowledge
