#### *Reasons/basis*

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include :-

When acting for clients in property transactions Ms von Wedel failed to comply with undertakings, failed to register purchases within the proper timeframe, failed to pay stamp duty within the proper timeframe, made misleading statements, sent offensive communications, caused improper transfer of client funds and failed to co-operate with the SRA investigation.

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.

3. Kirsten Von Wedel may not act as a compliance officer for legal practice (COLP) or compliance officer for finance and administration (COFA) for any authorised body.
4. Kirsten Von Wedel does not hold or receive client money, or act as a signatory to any client or office account or have the power to authorise transfers from any client or office account.

In these conditions the definitions are as defined in the SRA Glossary.

#### *Reasons/basis*

The above conditions are necessary in the public interest and reasonable and proportionate having regard to the purposes set out in Regulation 7 of the SRA Authorisation of Individuals Regulations and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.
