2. Mr Ioannou may not act as a compliance officer for legal practice (COLP) or compliance officer for finance and administration (COFA) for any authorised body, or head of legal practice (HOLP) or head of finance and administration (HOFA) in any authorised non-SRA firm.
3. Mr Ioannou may not hold or receive client money, or act as a signatory to any client or office account.

4. Mr Ioannou may not practise on his own account under regulation 10.2(a) or (b) of the SRA Authorisation of Individuals Regulations.
5. Mr Ioannou will immediately inform any actual or prospective employer or organisation to whom he provides consultancy services of these conditions and the reasons for their imposition.

In these conditions the terms are as defined in the SRA Glossary.

The above conditions are necessary in the public interest and reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.
