Policy development at the SRA is directed by the Executive, under the oversight of the SRA Board. We have a strong focus on stakeholder engagement throughout the lifecycle of our policy work, from early engagement with our Virtual Reference Groups right through to formal public consultation [\[sra/consultations/consultation-approach/\]](#) . Work with the panel is distinct from any of our wider stakeholder engagement activity,
